### Courses catalogue 2017-2018

The Department of Economics and Management offers six different study programs:

- one program at the bachelor level: BA in Economics (TREC);
- five programs at the master level: Business Administration (MBA), Economics and Finance (MEF), Economics Law (MED), Entrepreneurship and Innovation (EI), International Economics (MEI).

Courses are offered on a semester basis (semester 1 and 2), except for those belonging to the third year bachelor, where courses are offered on a tri-monthly basis (trimester 1, 2 and 3).
