\*In Italian Public Universities, there are two types of positions for Assistant Professors, 'ricercatore tipo A-rtda' and 'ricercatore tipo B-rtdb,' with differing lengths and possibilities but comparable responsibilities. The contract for 'ricercatore type A' is for three years and can be extended for just two more years after evaluation, but the contract for 'ricercatore type B' is for three years with no extension possibility. The distinction between the two types is that people with type B contracts have the possibility to pursue a career as an associate professor, whilst those with type A contracts do not. Both contract types include teaching responsibilities.
