The Department of Economics and Management offers five different study programs:

- o one program at the bachelor level: Bachelor in *Economics*;
- o four programs at the master level: *Business Administration, Economics and Finance, Economics Law, Entrepreneurship and Innovation*.

Courses are offered on a semester basis (semester 1 and 2), except for those belonging to the third year bachelor, where courses are offered on a tri-monthly basis (trimester 1, 2 and 3).


