Eligibility

Bachelor's degree or above

Completion of a bachelor's or higher degree program from an accredited college or university.

High proficiency in English

Indicators: TOEFL (IBT) ≥ 90 , IELTS ≥ 6.5 , Duolingo English Test ≥ 110 , PTE Academic ≥ 61 .

Majored in economics or finance or business related fields & solid knowledge in mathematics during the previous degree study (2-year program).

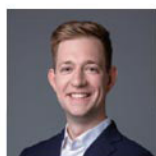
