- Exchange mobility (Europe)
- One semester abroad (first or second) or full year 2nd year
- Scholarship: about 300 € /month
- Call for selection: **deadline mid January 2019** <u>application in Uniweb</u>
- Learning agreement: study plan abroad to be approved before leaving









Double degree

- Partner univeristy: ESC Ecole Superièure de Commerce (FRA)
- Second year abroad
- Scholarship: about 650 € /month
- Call for selection: deadline end November 2018 <u>application in</u> <u>Moodle</u>
- Fixed study plan
- Two final degrees: Master in «Business Administration» from Unipd and Master Diploma, Programme Grand Ecole – PGE» from ESC







Double degree

- Partner univeristy: Baruch College NY (US)
- Second year abroad
- Call for selection: **provisional deadline December 2018** <u>application in Moodle</u>
- Fixed study plan









Summer school

- Partner univeristy: Guangzhou University (CHINA)
- 2 intensive weeks (end June-July)
- Scholarship: about 400 € / housing-canteen offered by Guangzhou
- Call for selection: February/March application in Moodle
- Intercultural management, prof. Campagnolo/Gianecchini (6 ECTS) + company visits
